### CALL TO ORDER

Pursuant to public notice, the meeting commenced at 3:10 p.m. with a Call to Order by Chairman Ken Haiko. Roll call was taken and quorum was established.

#### I. New Business

It is the intent of the board to provide Charter Schools USA with the necessary flexibility to manage school enrollment in a manner that achieves our objectives of high academic achievement and financial stability while staying within the boundaries of the approved operating budget and maintaining compliance with all contractual requirements of the charter.

- Enrollment capacity by grade level - Dennis Clark motioned that the board authorizes Charter Schools USA to modify grade level capacities within each charter school to meet actual demand in the community. Such modifications shall not result in exceeding the total enrollment capacity set forth in the charter contract or violate regulatory requirements for charter school facilities. Charter Schools USA is authorized to submit modifications of grade level capacities to the charter sponsor if necessary and will report any modifications to grade level capacities at the next scheduled board meeting. The motion was seconded by Clarence McKee. Motion passed.
- Current year enrollment capacity by grade level for Renaissance Charter School of St. Lucie - Dennis Clark motioned that the board authorizes the specific modified grade level configuration as provided by Charter Schools USA for the 2009-2010 school year.
