CALL TO ORDER

Pursuant to public notice, the meeting commenced at 10:34am with a Call to Order by Chairman Ken Haiko. Roll call was taken, and guorum established.

I. ADMINISTRATIVE

• Approval of the October 11, 2018 Board Meeting Minutes.

II. CSUSA REPORTS

Staffing and Retention

- Rachel Windler-Freitag, South Deputy State Director presented the overview of the Board's portfolio of schools instructional and non-instructional staffing turnover. Ms. Windler-Freitag presented the South Area school retention data and highlighted the top reasons for turnover based on exit-survey data which was: career change, not satisfied with the culture, and not satisfied with supervisor. The board discussed benefits, and requested a staffing comparison in February and comparing turnover data for August 2018 to January 2019.
- Jermaine Dawson reviewed the North Area schools and all questions were answered by Mr. Dawson and Mrs. Windler-Freitag.

Enrollment

- Mrs. Windler-Freitag presented to the board the enrollment summary which included capacity and October FTE counts with the districts.
- Mary Beth Greene, Principal of Renaissance Charter School at Wellington reported to the board the various activities and endeavors that the school is participating in an effort to improve enrollment.
- Rodney Hull, Principal at Keys Gate Charter High School reported to the board his efforts to outreach to the community and market the magnet program for the school.
- Katrina Samuels, Principal of Renaissance Charter School at Central Palm reviewed her enrollment as well as various opportunities that the school has for outreach to the community.
- Mr. Dawson reviewed the North Area School's enrollment and October FTE count and highlighted two schools that have opportunities for improvement.
- Dr. Bianca Brown, Principal of Renaissance Charter School at Poinciana, reported to the board her efforts at outreach and explained that her budget target was aggressive and that the targets will be more realistic for the upcoming school year.
- Julie Ramirez, Principal at Renaissance Charter School at Boggy Creek reviewed her school's enrollment numbers and how the early learning development center will provide an opportunity for increasing the school's pipeline for enrollment.

FY18 Audited Financial Review

Cindy Calvert, Sr. Partner at Keefe McCullough reviewed with the board the FY18
 Financial Audit Review and that the Firm has issued an unmodified opinion on all of the schools; financials. The Firm found no inconsistencies in governance and all Bond Series audits have been issued unmodified opinions. The board discussed the findings and requirements and all questions were answered by Mrs. Calvert.
