II. ADMINISTRATIVE

III. CSUSA REPORTS

Chief of Schools Update

- Rita Weaver, Director of Governance, thanked the board for attending the New American Hero event honoring the teachers.
- Mrs. Weaver updated the board on pending legislation that will allow CSUSA to continue the
 mobile learning model and being able to leverage the best teachers across the network of
 schools.
- Billie Miller noted that she has concerns for the teachers and schools if this is not implemented in a strategic way.

State Director Update

Dr. Eddie Ruiz updated the Board on Executive Order 20 which outlined options for FSA
grade reporting, high school graduation waivers, and creating a FAQ for parents to
understand that they must bring students in person for testing.

Facilities Update

- The Board reviewed the Facilities Updates for all the schools in the Southwest Charter Foundation, Inc. portfolio of schools.
- Dr. Ruiz updated the board on tax revenue that Duval County voted on that would allow the
 Duval schools to have additional capital improvement projects submitted and that CSUSA
 would bring those to the board at the June meeting. The board thanked CSUSA Facility
 Managers for the report and liked the format.

IV. FINANCE

FY21 Audit Engagement Letter

 The board reviewed the FY21 Audit Engagement Letters from Keefe McCullough for the Renaissance Charter School, Inc. portfolio of schools.

MOTION: Motion was made by Paul Sallarulo and seconded by Tom Wheeler to approve the FY21 Audit Engagement Letters from Keefe McCullough for Renaissance Charter School, Inc., as presented. Motion was approved unanimously.

V. OLD BUSINESS

Osceola Charter Application Update

• The Board discussed the April 20th Osceola School Board hearing date for the School Board to vote on the two new charter applications.

Charter Renewal Updates

Rita Weaver updated the board that Duval School Board Attorney has sent over the
contracts for Duval Charter High School and Duval Charter School at Westside for review
and it is the model contract with some minor changes. The recommendation was for a
15 year and 5-year renewal, respectively. The Renaissance Charter School at Plantation
contract was sent to the School Board for approval. The Keys Gate Charter High School
contract is currently in negotiations with Miami Dade County Public Schools.

CARES Grants II Update

 Rita Weaver updated the board that districts are starting to announce the allocations for each of the schools and that the draft budgets are being submitted and will be brought before the board once the districts have approved them.

Teacher Certification Extension

The board reviewed the letters of request for extensions on teacher certification in the
packet. Ms. Miller is concerned that so many teachers have had their certifications get
so close to expiration and hopes that there is monitoring at the leadership level
occurring. Dr. Ruiz outlined the process and assistance being given to teachers to
maintain certification.

MOTION: Motion was made by Billie Miller and seconded by Paul Sallarulo to accept and submit the request for deadline extensions of teaching certificates, as outlined and presented. Motion was approved unanimously.

VI. NEW BUSINESS

Out of Field Waivers

· The Board reviewed the out of field waivers.

MOTION: Motion was made by Billie Miller and seconded by Dennis Clark to approve the out of field waivers presented. Motion was approved unanimously.

School Year 2021-22

- The board reviewed the SY22 calendars which noted the following:
 - Miami Dade County schools switched two professional development days for instructional days in order to have the full Thanksgiving break;
 - Broward has the same full day instructional days and one additional early release day;
 - Palm Beach is following the Palm Beach district calendar and added in 2 school days for 12 month employees;

- St. Lucie has the same number of instructional days as the district with 2 different professional development days;
- Osceola schools follow the Osceola district calendar;
- o Orange schools follow the district calendar with different weather make up days;
- Duval schools follow the district calendar;
- o Governors Charter Academy follows Leon district calendar.

MOTION: Motion was made by Dennis Clark and seconded by Billie Miller to approve the SY22 Calendars for the Renaissance Charter School, Inc. portfolio of schools, as presented. Motion was approved unanimously.

- The board reviewed the Security Contracts and Coverage to comply with the MSD law, which noted the following:
 - o The three Guardians employed by Renaissance Charter School, Inc. will not be renewing the contracts and will have coverage by Dynamic Integrated Security. All other Broward schools will maintain present coverage;
 - o Dade, Duval, Orange, Osceola, Palm Beach, and St. Lucie will maintain the present coverage;
 - o Governors Charter Academy will move to Dynamic Integrated Security.
- Tom Wheeler, the Security Committee member, advised the board that he does not think it is in the Board's interest to have security employees and is happy to see that CSUSA is arranging for the Board to contract to meet the MSD Law requirements.

MOTION: Motion was made by Dennis Clark and seconded by Billie Miller to approve and authorize the Chairman to execute the Security coverage as outlined to comply with the MSD Security Law, as presented. Motion was approved unanimously.

The board reviewed the SY22 enrollment policy which complies with state statute.

MOTION: Motion was made by Dennis Clark and seconded by Paul Sallarulo to approve the Enrollment Policy for the FY22 School Year, as presented. Motion was approved unanimously.
