  - CSUSA Leadership updated the Board on an opportunity for a Performance Based Charter agreement with Escambia County for Warrington Middle School, which terms were reviewed. The Board discussed the impact of assisting with students and the necessity to create a support team for the panhandle area to include Governors even though Tallahassee and Escambia are 3 hours apart. CSUSA would create an on the ground support team.
  - The Board's concerns included: Staffing for the August start date in May, financial support, and distance from the other RECS schools for support. The Board also requested that the leader that will be appointed for the school be an experienced CSUSA Education Model Leader,
  - The Board requested the following for the next Board meeting: Leadership announcement, teacher compensation, and a presentation with the panhandle plan, including a budget and an executable timeline.

MOTION: Motion by Tom Wheeler and seconded by Billie Miller to accept and enter into a land Lease with Escambia County School District, as presented before this Board, with the provision that this Board authorizes; that should any further negotiations result in changes approved by the Chair and Board Counsel, the subsequent land Lease is hereby adopted by this Board and the Chair is authorized to enter into same with the full authority of this Board. Motion was approved unanimously. (6-0)

MOTION: Motion by Dennis Clark and seconded by Pat Smith to accept and enter into a Performance Based Charter Agreement with the Escambia County School District, as presented before this Board with the provision that, this Board authorizes; that should any further negotiations result in changes approved by the Chair and Board Counsel, the subsequent Performance Based Charter Agreement is hereby adopted by this Board and the Chair is authorized to enter into same with the full authority of this Board. Motion was approved unanimously.

MOTION: Motion by Billie Miller and seconded by Tom Wheeler to accept and file the Application for School of Hope presented before this Board with the provision, that this Board authorizes; that should any further changes approved by the Chair and Board Counsel, the subsequent Application for School of Hope is hereby adopted by this Board and the Chair is authorized to enter into same with the full authority of this Board. Motion was approved unanimously.
