# **CALL TO ORDER**

 Pursuant to public notice, the meeting commenced at 10:30am with a Call to Order by Chairman Ken Haiko. Roll call was taken, and quorum established.

#### II. ADMINISTRATIVE

# Approval of the December 5, 2023, Renaissance Charter School, Inc. Board Meeting Minutes

 The board reviewed the meeting minutes from December 5, 2023, Renaissance Charter School, Inc. Meeting.

MOTION: Motion was made by Paul Sallarulo and seconded by Billie Miller to approve the meeting minutes from the December 5, 2023, Renaissance Charter School, Inc. board meeting. The motion was approved unanimously. (5-0,1 absent)

#### III. CSUSA REPORTS

# State Superintendent Update

- State Superintendent, Dr. Eddie Ruiz thanked the school, Duval Charter at Westside for hosting the meeting and updated the board on the following:
  - Duval Charter School at Mandarin and Duval Charter School at Southside received 15year renewal with the district
  - High School graduation rates increased for all Renaissance high schools. Accountability changes and the new scales for school grades which include the buckets for combination schools Now there are four areas for grades.
- Dr. Ruiz reviewed the school dashboards for the Tier 3 schools in the Renaissance Charter Schools
  portfolio of schools. Dr. Ruiz recognized Area 5 Deputy Director, Christina Hamlin for her
  presentation at the CSUSA mid-year accountability retreat.
- The board requested an update on schools that have been flagged for ESSER grant reimbursement balances pending.
- Dr. Ruiz provided an update on Warrington Preparatory Academy. Instructional software has been instrumental at Warrington, and we have a team that is assisting at the school. Warrington received the Triumph Gulf Coast Grant for work force readiness. The school is projecting high learning gains for the students.
- The board reviewed FY25 Enrollment targets for all of the Renaissance Charter School, Inc. schools.
- Dr. Ruiz provided the Principal and Assistant Principal Salary Increases, previously requested by the board and outlined the two-phase approach.
- The board reviewed the salary brackets for each position by county and noted some were still lower than the districts. CSUSA will always try to keep pace with the district from a salary perspective but sometimes it is difficult to do so as each school has their own unique budget whereas a district school does not. He noted these are two phase increases and the presentation included phase one of the increase.
- Dr. Ruiz, we will meet individually with each leader and discuss the increase. In April or May, we
  will provide a final increase to the principals.

MOTION: Motion was made by Billie Miller and seconded by Pat Smith to approve the State Superintendent Report, as presented. The motion was approved unanimously.

# CSP Grant Application Update - Warrington Preparatory Academy
